

Waiver of Liability

I understand that I am signing this waiver (this "Waiver") and agreeing to its terms as a condition to and in consideration of my entry onto the premises surrounding Dolphin Stadium (the "Stadium") and into the Stadium in connection with the tour of the Stadium premises (the "Tour") provided to me by the National Football League ("NFL").

I understand that the Stadium, in its preparation for the Super Bowl Game, is an active and operating work site, and that there may be risk of serious injury to person and property, among other risks either not known to me or not readily foreseeable at this time, while participating in the Tour or while on the Stadium premises.

I am voluntarily participating in the Tour with knowledge of the danger involved and agree to accept and assume all risks of participation, including, but not limited to, personal injury, wrongful death, property damage or loss incidental to entering into the Stadium or onto the Stadium premises, and hereby release and agree to hold harmless Miami Dolphins, Ltd., South Florida Stadium LLC, National Football League, its member professional football teams, NFL Management Council, NFL Properties LLC, NFL Ventures, L.P., NFL Ventures, Inc., Ticketmaster and each of their respective representatives, employees, subcontractors, sponsors, licensees, agents, affiliates, subsidiaries, parents, owners, officers, directors, shareholders and lessees of the premises (collectively, the "Released Parties") from all present and future claims, liabilities, obligations, damages, losses, demands, costs or expenses (collectively, "Claims") that may be made by me, my family, estate heirs, or assigns for property damage, personal injury, wrongful death, or loss arising as a result of my participation in the Tour and related activities, even if caused by the Released Parties' ordinary negligence wherever, whenever or however the same may occur. I consent to administration of first aid and other medical treatment in the event of injury or illness.

I agree that without any further consideration from the Released Parties, to grant the Released Parties the unlimited right throughout the world to use my name, nickname, image, likeness, voice, photograph, signature facsimile, and biographical information in any matter and for any purpose in any media now known or hereafter existing in perpetuity. I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the state in which the Tour is taking place and agree that if any portion of this Waiver is invalid, the remainder will continue in full legal force and effect.
